College, I am directed to say that the Government in Higher Education Department has 'No objection' for establishment of a self financed B.Ed. College in the name of Berhampore B.Ed. College, Distt. Murshidabad, strictly on self-financing basis subject to approval of the National Council for Teacher Education and affiliation by the Kalyani University and also fulfillment of the following terms and conditions:

The proposed college shall be guided by NCTE norms in respect of appointment of teaching staff, purchase of books, audio-visual material and automation of the library.

The College will continue to organize and equip the laboratories as per stipulation of NCTE.

Other infrastructure to be maintained as per NCTE.
